




Curriculum Policy

September 2017

1.0 Introduction

- 1.1 The purpose of this policy is to ensure that our curriculum supports our school ethos and fulfils our school aims which in our school are defined as:
 - Inspire Achievement
 - Nurture Individuality
 - Create Opportunity
 - Look Forward
- 1.2 We see the curriculum as, 'The total learning experience for our pupils, which includes not only the taught lessons but also the routines, behaviours, events, activities and other opportunities that our pupils experience on a daily, weekly and yearly basis in order to ensure that all of them make the best progress possible and attain high standards'.



- 1.4 We aim to provide a curriculum to develop pupils who love learning. We understand that the curriculum, both within taught lessons and beyond them, and in everything we say and do, should create an environment where academic risk-taking, questioning and debating, challenging thinking and the freedom to learn from mistakes are all encouraged.
- 1.5 Our curriculum offers all pupils the opportunity to experience linguistic, mathematical, scientific, technological, human and social, physical, aesthetic and creative aspects of education. We intend that our curriculum should imbue in our pupils:
 - A passion for life-long learning;
 - A capacity for independent and critical thinking;
 - Self-awareness, self-regulation and resilience;
 - Self-confidence without arrogance; and
 - Genuine interests that extend beyond the confines of the classroom.
- 1.6 British Values, which are democracy, the rule of law, individual liberty and mutual respect and tolerance of those with different faiths and beliefs, are actively promoted in every aspect of school life.

2.0 Taught curriculum

2.1 Our taught curriculum broadly follows and, at times, goes beyond the Early Years Foundation Stage and National Curriculum at KS1 and is formally assessed at the end of Reception by the Early Years Foundation Stage profile. Our pupils also take GL assessments at the start and end of year 1 in English and Mathematics.

2.2 Taken together, the taught curriculum will ensure that by the time they have completed their time with us, all pupils are able to demonstrate the knowledge, skills and understanding to enable them to move onto the next stage of their education at the highest level.

3.0 Special Educational Needs and Disability - SEND

3.1 Our curriculum is inclusive. For those pupils with special educational needs or specific learning difficulties, the school has a SENCo to suport and guide the school on the best provision within the curriculum to support good progress for each child.

4.0 SMSC

- 4.1 Our policy follows the advice given by the DfE in the non-statutory guidance of November 2014 and meets the requirements of the Independent School Standards. Aspects of SMSC are infused within the day to day operation of our school; incorporated through the curriculum, both in content included in subject schemes of work and through other planned learning opportunities in the school. They are captured in our written aims and expressed in the ethos and behaviours of everyone. Our approach to SMSC ensures that principles are actively promoted which:
 - Enable pupils to develop their self-knowledge, self-esteem and self-confidence;
 - Enable pupils to distinguish right from wrong and to respect the civil and criminal law of England;
 - Encourage pupils to accept responsibility for their behaviour, show initiative and understand how they can contribute positively to the lives of those living and working in the locality in which the school is situated and to society more widely;
 - Enable pupils to acquire a broad general knowledge of and respect for public institutions and services in England;
 - Further tolerance and harmony between different cultural traditions by enabling pupils to acquire an appreciation of and respect for their own and other cultures;
 - Encourage respect for other people, paying particular regard to the protected characteristics set out in the 2010 Act; and
 - Encourage respect for democracy and support for participation in the democratic process, including respect for the basis on which the law is made and applied in England.
- 4.2 Discriminatory or extremist opinions or behaviours are challenged as a matter of routine.
- 4.3 In addition, our approach to SMSC ensures that all pupils will gain, in an age appropriate manner. an:
 - Understanding of how citizens can influence decision-making through the democratic process:
 - Appreciation that living under the rule of law protects individual citizens and is essential for their well-being and safety;
 - Understanding that there is a separation of power between the executive and the
 judiciary, and that while some public bodies such as the police and the army can be
 held to account through Parliament, others such as the courts maintain independence;
 - Understanding that the freedom to hold other faiths and beliefs is protected in law;
 - Acceptance that people having different faiths or beliefs to oneself (or having none) should be accepted and tolerated, and should not be the cause of prejudicial or discriminatory behaviour; and
 - Understanding of the importance of identifying and combatting discrimination.

5.0 Religious Education and PSHEE

5.1 Our school chooses, for Year 1, to respond to the legal requirement in maintained schools to teach Religious Education and Sex and Relationships education, and to non-statutory guidelines to cover other aspects of Personal, Social, Health and Economic Education (PSHEE).

NOTE: In the Early Years, the areas of learning of Understanding the World and Personal, Social and Emotional Development cover these areas.

5.2 Our PSHEE course is delivered every day throughout every session in Early Years as part of pupils Personal, Social and Emotional Development and is integral to our Early Years curriculum. In Year 1 it is delivered through discrete PSHEE lessons taught by their class teacher. There is one lesson of taught PSHEE a week. This includes Sex and Relationships Education (SRE) and Drugs and Alcohol Education. Elements of the programme may be supported through the bringing in of additional expertise such as outside speakers or the use of teachers with a particular interest or knowledge in a specific area. In addition to these discrete sessions, PSHEE is also dealt with across the curriculum as part of our culture and ethos in the school.

6.0 Co-curricular

- 6.1 A wide range of enrichment activities supplements the timetabled curriculum. Our pupils are encouraged to take part in a range of art, drama, music, sport and other activities and clubs as appropriate for their age. Regular themed days and weeks are held. These may include Book Week, International Week, Science Week, Anti-Bullying day, pirate day, beach day or our Teddybears Picnic for example.
- 6.2 Pupils are taken to places of interest on a regular basis as appropriate for their age. Visits are organised to link to classroom topics and themes which help to develop independence, teamwork and responsibility in a different environment to that in school.
- 6.3 Visitors to the school are also arranged to supplement and complement the taught curriculum such as visits by museums, storytellers or drama workshops.

7.0 Other opportunities

- 7.1 Our school aims to provide an education for life. Other aspects of our curriculum which enable our pupils to gain the skills, knowledge and experience to be successful adults may include:
 - Fundraising Activities;
 - School council;
 - Healthy Schools council;
 - Eco council
 - Rights Respecting Council

8.0 Responsibility

- 8.1 The person with responsibility for the overview and yearly evaluation of this policy is Vanessa Conlan. However, all staff are responsible for ensuring this policy is implemented and acted on.
- 8.2 When evaluating the use and impact of this Curriculum Policy, our school leaders will evaluate the extent to which there is evidence of a curriculum which:
 - Fulfils the aims of the school;
